

## **WOODLANDS - Registration Process**

1. Complete the registration form (front AND back)
2. Mail or return form along with a **\$100 non-refundable\*\*** deposit to:

3. Watch for a confirmation email with instructions about how to complete the rest of your child’s registration online.
4. Regular ALIVE attenders will get a spot for Woodlands before those who don’t attend regularly.
5. Remaining balance to be paid on or before:
  - June 7 (Middle School - \$470 total)
  - July 5 (High School - \$495 total // Xtreme - \$595 total)

- Please note for Middle School camp that we can’t give a refund of your remaining balance of \$370 after June 7.

- Please note for High School camp that we can’t give a refund of your remaining balance of \$395 (\$495 for Xtreme) after July 5.
